- A) Price Schedule (BOQ) item no. 2.04: The gauge of welded mesh is 10G instead of 16 G
- B) Price Schedule (BOQ) Item no. 4.04: Dia. of MS bar is missing, 6 mm dia. MS bars are to be provided. The nomenclature of Item stands corrected accordingly.
- C) Price Schedule (BOQ) Item No. 8.04: Unit may be read as sq. m. Instead of R.mt.
- D) Price Schedule (BOQ) item no. 8.07: Unit may be read as sq. m. Instead of Nos.
- E) Price Schedule (BOQ) Item No. 12.14. a) 15 litres capacity vertical wall mounted with steel 304 grade or glass lined High pressure water tanks of make AOSmith/Racold/Philips/Havells (onsite service guarantee for 2years or more)
- F) NIT condition no. 15: The word ARCHITECT/ENGINEER In charge is substituted with word PRINCIPAL SGNDKC.
- G) The word OWNER is Substituted with word PRINCIPAL SGNDKC in the tender document wherever word owner is mentioned.
- H) ARCHITECTS STATUS AND DECISIONS point no 9. Extension of time will be granted on recommendation of Architect by the Principal with Prior approval of college building committee and chairman/GB
- Taxes: Following Line are added." Rates quoted are inclusive of Labour cess, Excise, or any other cess etc. nothing extra is payable. TDS shall be deducted by the college wherever it is applicable as per Govt. rules.
- J) Certificate of payment: Following is added "All running bills/ payments for the work made by the college, shall be treated as advance payments, adjustable in the Final Bill of the contractor. Any over payments made in the bills WILL BE RECOVERABLE from contractor 's final bill security deposit etc. contractor is liable to refund such money if at any stage it is found as over paid as result of Govt. Audit or collage authorities.
- K) ARBITRATION: The word Architect is substituted with word Principal SGNDKC and modification that matter can be referred to sole or panel of Two arbitrators of technical, legal or *Member of Council of Architects (COA)* with the approval of Chairman/Governing body of the college.
