CODE OF CONDUCT FOR STUDENTS

- I The following code of conduct is intended for all students who are currently on the rolls of the college to help them develop their full potential and inculcate ethical values so that they become responsible, law-abiding citizens in their professional life. The key principles governing the code are as follows:
 - 1. Respect for Rules, Policies, procedures and practices framed by the college administration for smooth functioning of the Institute.
 - 2. Respect for fellow students, faculty and non-teaching staff
 - 3. Respect for Environment.
- II All students are required to abide by the above-mentioned key principles and the responsibilities and restrictions flowing from these. Specifically, the following acts shall be viewed as serious misconduct.
 - (i) Incidents of ragging by students on the College campus of outside.
 - (ii) Sexual harassment of other students of the college.
 - (iii) Any physical or verbal conduct that discriminates other individuals based on their gender, race, religious beliefs, caste, colour, region, language or family status.
 - (iv) Physical assault, threat of violence or a conduct that threatens the safety of any person on the college premises.
 - (v) Sale and distribution of prohibited substances such as drugs, alcohol and cigarettes;
 - (vi) Damage and disfiguring of college property or property of other students and college employees.
 - (vii) Any disruptive activity in the class or other events that disturb the academic and social environment.
 - (viii) Audio and video recordings of events and other persons in class or on campus without prior intimation and consent.
 - (ix) Conduct that adversely affects the college reputation and/or constitutes as nuisance to members of community living around the college campus. This includes

- assembly, procession and protests, parking vehicles irresponsibly, creating unreasonable noise, loud music, lewd and indecent comments, littering, drinking alcohol and taking drugs outside the college campus.
- All Sikh students are required to wear the turban respectfully within the college premises.

The list is indicative and not necessarily exhaustive.

- At the time of admission each student shall sign a statement accepting this code of III conduct and by giving an undertaking that:
 - He shall be regular in attending the classes and completing the courses opted by him/her;
 - (ii) Pay all legitimate dues and fees on time;
 - (iii) Carry his/her identity card at all times and present it when requested by the security personnel;
 - (iv) Use social media responsibly and not post any indecent comments and derogatory comments about other individuals of the college that may have grave ramifications on r reputation of other individuals and college.

IV If any incident of possible breach of the above-mentioned code is reported or noticed by the college authorities then a Committee constituting three members of faculty shall be formed to inquire into the alleged violation and recommend a suitable disciplinary action. The Principal of the College shall be the final authority to review the recommendations of the Committee and take disciplinary action. Disciplinary action may include a warning, restriction to certain college facilities, monetary penalty or expulsion based on the past academic and social record of the student, the nature and severity of the misconduct.
