"The National Commission for Minority Educational Institutions (NCMEI) vide its order dated 19th July 2011, has granted the minority community educational institution status to Sri Guru Nanak Dev Khalsa College. The minority community institutions are exempt from reservations for SC/ST and OBCs. Therefore, 50% seats will be reserved for the Sikh minority students and 50% seats shall be filled as general seats. Reservation for physically challenged, sports and extra-curricular activities, army personnel and war widows, foreign students etc. shall continue as per University of Delhi norms in respective categories."

Admission Policy for minority Sikh Students in the Colleges maintained by Delhi Sikh Gurdwara Management Committee and affiliated with University of Delhi

Sir,

Delhi Sikh Gurdwara Management Committee represents the Sikhs in Delhi and manages many Gurdwaras and educational institutions including institutions of higher learning in Delhi. Four of our Colleges i.e. Sri Guru Tegh Bahadur Khalsa College, Sri Guru Gobind Singh College of Commerce, Sri Guru Nanak Dev Khalsa College and Mata Sundri College for Women are the constituent Colleges of the University of Delhi. These colleges have been declared minority educational institutions by the National Commission for Minorities Educational Institutions, Government of India. The Hon'ble High Court, Delhi has also endorsed three of our Colleges namely Sri Guru Gobind Singh College of Commerce, Sri Guru Nanak Dev Khalsa College and Mata Sundri College for Women as Minority Educational Institutions. The case of Sri Guru Tegh Bahadur Khalsa College is subjudice and likely to be decided soon.

We submit that we shall follow the following admission policy for three colleges which have been endorsed as Minority Educational Institutions;

- For Entrance based courses like (a) BMS and (b) B.A. (Hons.) Business Economics,
   (c) B.El.Ed, the colleges will follow University admission process. However we request
   University of Delhi to make a separate category for Sikh Minority students and allocate it to these colleges separately as per seat allocation to these colleges.
- 2. For all other courses based on Cut-Off, these colleges will follow University Registration process. The colleges will accept students (General as well as Minority) who have registered centrally with the University of Delhi. However to make admission more accessible to Sikh Minority Students, these colleges will additionally register Sikh Minority Students on its own and accept them for admission too.

This is with reference to your letter no. DSW/2016/443 dated 05.05.2016 seeking information regarding the college's admission to Undergraduate courses in view of minority status granted to the college.

Sri Guru Nanak Dev Khalsa College, Dev Nagar, New Delhi 110005 has been granted Minority status by Honourable High court of Delhi. As per guidelines of NATIONAL COMMISSION FOR MINORITY EDUCATIONAL INSTITUTIONS, our college is entitled to reserve 50% of total allocated seats to Sikh Minority Students.

As regards admission of students, the college will be observing the following policy.

- 1. For Entrance based courses like (a) B.A. (H) Business Economics, the college will follow University admission process. However the college will require the University of Delhi to make a separate category for Sikh Minority students for admitting them as per Minority Status.
- 2. For all other courses based on Cut-Off, the college will follow University Registration process. The college will accept students (General as well as Minority) who have registered centrally with the University of Delhi. However to make admission more accessible to Sikh Minority Students, the college will additionally register Sikh Minority Students on its own and accept them for admission too.

I hope this has clarified our position with regard to admission policy for academic session 2016-17.

Subsequent to the notification by the National Commission on Minority Educational Institutions declaring Sri Guru Tegh Bahadur Khalsa College, Sri Guru Gobind Singh College of Commerce, Mata Sundri College for Women and Sri Guru Nanak DevKhasla College as Sikh minority educational institutions and the judgement delivered by the Delhi High Court, Delhi Sikh Gurudwara Management Committee has resolved to admit Sikh Minority students in coming academic Session 2016-17 in Sri Guru Gobind Singh College of Commerce, Mata Sundri College for Women and Sri Guru Nanak DevKhasla College, to the extent of 50% of the total allocated seats in various courses being run in these colleges. Admission for the Sikh Minority students in Sri Guru Tegh Bahadur Khalsa College is subjudice andis likely to be resolved soon. All these colleges are affiliated to University of Delhi.

Admissions of Bachelor in Management Studies (BMS), B.A. (Hons.) in Business Economics(BBE) and Bachelor in ElementaryEducation (B.El. Ed) are entrance based for which entrance test will be conducted by the University of Delhi. All the Sikh Minority students seeking admission in these courses should apply to the University of Delhi directly for admissionas per the eligibility norms of University of Delhi. BMS and BBE courses are highly professional courses and are designed as per the requirement of the corporate sector in finance, marketing, human resource management, business analytics, e-marketing and services. B. El Ed. Is available at Mata Sundri College for Women and is extremely useful with almost complete placements in the schools.50 percent of the seats will be filled by the Sikh Minority students in the above mentioned Khalsa Colleges.

However admission to the other following courses for the Sikh students will be done by the colleges directly. These courses are:

B.A. (Hons.)in English, Mathematics, Punjabi, Hindi, Economics, History and Political Science

B.A (Prog.)

B.Com (Prog.)

B.Com. (Hons.)

B.Sc. (Prog.) Life Sciences and Physical Sciences

B.Sc. (Hons.) Botany, Chemistry Electronics, Mathematics, Physics, Zoology.

In view of the above all the Sikh Minority students are advised to register their names directly in the Khalsa Colleges for admissions. General Category students are advised to register in University of Delhi and they will be eligible for admissions for non-minority seats. However the minimum eligibility norms for all the categories will be as per University of Delhi notifications from time to time.

The certificate of Sikh Minority students will be issued by the Delhi Sikh Gurdwara Management Committee through its office of Gurdwara Rakab Ganj Sahib, New Delhi. In view of the above the all the Sikh students desirous of seeking admission are advised to seek clarifications and guidance from the respective colleges.
